Chapter Recognition Awards

One of the more successful ways History can be taught to today's generation is through historical markers and monuments placed near the site of some significant event, place, or person in history. Local chapters of SUP are encouraged to learn about the history of their surrounding area and be continually engaged in a monument or marker project.

#### **EXISTING MONUMENTS**

As important as it is to erect historical monuments, it is equally important that they be maintained. Both the effects of nature and of man can dim the beauty of the markers making the historical significance of the area less appreciated. Materials for building monuments or markers should be chosen carefully and with professional advice to assure lasting beauty, and establish a program of periodic cleaning and restoration. Chapters should use caution in using cleaning solutions that may further damage a marker. Expert advice should be sought.

In many instances there may be monuments in your area erected by others whose organization is no longer functioning. An example of such a situation is the Utah Pioneer Trails and Landmarks Association, (UPTLA), who were organized in the 1930's by George Albert Smith and others, and who erected, often with others, more than 130 monuments during its 25+ year history. In recent years, and at the request of the remnants of the organization, the SUP has assumed the responsibility for locating and recording these historic markers along with our own. Restorations have also been conducted for them and also DUP markers (with their permission) as well. A search in your area should be conducted to see if there are any of these that need attention.

#### **CREATING NEW MONUMENTS**

Under the direction of a Committee Chairman, committees are to identify trails, events, persons and sites, recorded in pioneer journals or other histories, both early and modern, and to recommend appropriate memorials or markers. This usually means donating hundreds of hours of labor in planning and constructing attractive monuments or markers complete with well-documented details of the event or place being commemorated. In many cases, the chapter will solicit cooperation from other agencies or participate with other

agencies in the marker or monument project. Funds to finance the project are raised through donations and fundraising activities and are the responsibility of the chapter. Publicity surrounding the dedication of the historical marker is arranged by the chapter and a complete report of the entire process is to be filed with the National Society to be permanently in the SUP Library.

The National Program Director and National Committee Chairmen are available for consultation and advisement with each of the chapter's standing and ad-hoc committees.

When a Chapter plans a plaque, monument or to mark a trail, the committee must decide what the subject will be, where it will be placed, and get permission to put the marker there. Notify the National Program Director of your plans.

When a monument is placed on private property, there should be an agreement as to who will own and maintain it. When one is placed on public land, ownership likewise needs to be determined and legal clearances need to be obtained from the appropriate planning commissions, legal departments, elected officials, parks departments, or whomever has jurisdiction, whether it be state, county, city or other municipal entity. Beware of "hold harmless" legal clauses shifting liability from the municipality to the SUP.

The National Society must approve all copy and illustrations, and the application form signed by the National Program Director and a National Officer, so that duplications can be avoided and a record established. It will be given a number that can be used on the monument with the SUP logo. The chapters are responsible for the cost and placement of all markers/monuments they install. Since the information needs to be suitable for placing on the Website, it is preferable that pictures be taken with a digital camera and sent in jpg form by email or on a CD or DVD disc to the National Monuments Director. A close-up picture, full-view picture and location view are desired. Additional pictures can add even more meaning.



#### JOSEPH HOLBROOK

"I, Joseph Holbrook, being desirous of leaving on record a few of the incidents of my past life and also a genealogy of my forefathers that my children may be somewhat acquainted of the origin of their forefathers. And I have written it in the English language hoping it will prove a blessing to them and be held sacred in my family from generation to generation, as I shall embrace in it my experience and the knowledge I may have gained in the course of my days. And I pray the Lord to direct my pen, assist my memory, correct my



#### **LEARNS OF MORMONS**

During the summer of 1832 Joseph heard vague rumors of a people who were called Mormonites, and after reading articles published in the Evening and Morning Star which was published in Jackson County he became deeply interested and desired to obtain a Book of Mormon and finally thru his cousin Mary Ann Angell and an Elder by the name of John Green he was able to borrow one. He started to read the book on a Friday night and the next day he could not content himself at work in the field so came to the house and read some more. His wife was alarmed to think that he left his work to read what she thought to be nonsense, so he again went out to the fields to work. This was futile, however, so he went into the adjoining woods to pray and through inspiration again returned to the house and kept on reading and continued to do so even on the next day which was Sunday. He finished the book in two days and three nights and then returned the book to his cousin telling her that he believed it was true and that God was at the bottom of the work and that he would like to meet the elders.

Joseph found that the Book of Mormon had shed new light upon the Bible. It, the Bible, literally became a new



book to him and in the absence of the Elders he studied both books diligently. He prayed constantly about the matter and received a marvelous manifestation in answer which he has recorded in his own words. The Abraham Morton family opposed him in every way and said he was bringing disgrace on the family in defending the Mormons and their beliefs. Neverthless when he met two elders (Aaron C. Lyon and Lenard Rich from Warsaw) one night as he was going to milk his cows and they informed him a meeting was going to be held at Warsaw he

decided then and there to attend.

#### **JOSEPH IS BAPTIZED**

Joseph was so certain that he wanted to be baptized that he took clothes for that purpose along with him to Warsaw and was granted permission being baptized on Sunday morning Jan. 6, 1833, along with his aunt Pheobe Angell by Lenard Rich. Meetings were held during the day and evening. Windson C. Lyon spoke in tongues and many wonderful testimonies were born. The next morning Joseph's wife Nancy was convinced that the Gospel as taught by the Mormons was true and applied for baptism. She was baptized by Lenard Rich and confirmed by Aaron C. Lyons Monday Jan. 7, 1833. Joseph was then ordained a teacher by Aaron C. Lyons. Upong returning home he met with opposition on all hands and from every side and quarter but this only served to keep him all the more faithful and diligent in spreading the Gospel.

In the course of just a few months the elders along with the help of Joseph were instrumental in bringing 85 people into the Church. Many had the gift of tongues, interpretation, gift of prophecy under the influence of the Holy Ghost. They met together often to preach, exhort and speak to one another of the things of the kingdom which gave them love for one another, strengthening of their faith etc.

In the journal written by himself, Joseph gives in detail accounts of the trials they went through. In November 1838, the mob burned his house, stole his cattle, and used about 300 bushels of grain. His wife was in very poor health from

exposure, as they had no home, they lived among friends as best they could. The mob was searching for him so he had to leave and hide. He was gone three months and returned to find his wife with a baby daughter, born one week after he left.

In July 1842 his wife Nancy died at Nauvoo, leaving him with four children. He married Hannah Flint January 1st, 1843. She was a school teacher. The hardships he was called to go through undermined his health and he had a severe sickness but through faith and prayers of the saints he was healed. He had been sick a year at Winter Quarters.

#### DEPARTURE FOR UTAH


June 1848, they left for Utah, arriving in Salt Lake City September 20th, 1848. March,1850 he moved to Sessions settlement later known as Bountiful, Utah. Jan. 16, 1851, he was appointed first Judge of Davis County. With the help of Daniel Carter and Orman Leonard they organized the county into school districts and precincts to hold elections, highway districts for roads and appointed water masters for irrigation purposes, etc.

December, 1856, he resigned as Judge as his health was poor. From his journal "I have served six years and have taken nothing from the public treasury for services and have done all I could to promote the public good. The court house was built from the taxes as most of the officers served

without pay. It is the first court house built in the territory and cost \$6,000.00, Henry Miller taking the job of building. It was nearly paid for during my term of office. The county has been divided into districts and all has prospered."

He served in the state legislature from 1859 to 1862 inclusive, it being held at the court house in Salt Lake City. January 20th, 1864, he was again appointed Judge of Davis County. There was a company of "Silvergrays" formed in the south portion of Davis Co. and mustered into service on the 8th day of August 1857, from members of the Nauvoo Legion. They were called the "Mountain Sharps." He was chosen captain. The company consisted of men over 45 years of age and stationed in Bountiful City for home guards.

His journal is one of the most faith-promoting stories one can read and shows what loyalty to God and his church was given by those sturdy pioneers. "Not what we give, but what we share; the gift without the giver is bare." When the tabernacle at Bountiful was being built he had an amusement hall being built at the same time. just over the east side of the block from the church. He gave his shingles to the church and his own building stood for years with only slabs as covering. He doesn't mention it in his journal but says, "If one gave more than another, it is because they had it and the ability to do so, and they do not wish to be lauded for having done that which according to the scripture was their duty to do so."

Along with Ashley's wife, Lorna and his daughter Nicole Dominguez, we watched a power point presentation with comments from the Hall family. Part of the Old Spanish trail goes through the Fort and a marker has been placed there. We learned about the Old Fort and saw parts of the original adobe that was used to build the Fort.

We then headed to the Old Spanish Trail Park in Las Vegas, NV. We found the trail marker which is on the Old Spanish Trail which we could see. We received more information from the Halls and enjoyed our lunch at the Park.

We headed towards Blue Diamond, NV, where we stopped at the Late-Night Trail Head and marveled at the huge silhouettes put up by the BLM showing a mule train which animals were used on the Old Spanish Trail.

Our final destination was at the turn-off for Sandy Valley, NV. There is an Old Spanish Trail Marker placed there and clear view of the trail itself.

It is the 150th year since the historic completion of the First Transcontinental Railroad, connecting east to west with the driving of the Golden Spike at Promontory Summit, Utah, May 10, 1869. She recalled experiences she has had working with various groups preparing for this event including working closely with Chinese Railroad Workers Descendant Association and the California Pioneers Heritage Foundation.

Many activities have been planned for this event, including a Royalty Pageant, a reenactment of the driving of the Golden Spike, and many activities on Washington Blvd in Ogden. It will be closed May 9th to accommodate the many trains that will be on display. The members of the commission are expecting a very large turnout for this event and she urged us all to plan ahead and get tickets early. For more information about this event go to: Spike150.org.

Sister Seale closed by reminding us of the importance of this monumental occasion. She explained that the completion of the Transcontinental Railroad was a blessing to the pioneers because it paved the way for many more people to come to Utah and allowed for the continued growth of the Utah Territory.

His subject matter was Abraham Lincoln and

Lincoln's stand on civil and religious freedom - a subject which Lincoln spoke of often. Ron stated there were two major flaws in the Constitution of the United States that Lincoln wanted to fix:

- 1. Slavery the constitution could not be ratified by some delegates if slavery wasn't allowed to remain.
- 2. Some states did not want to be obligated to follow the

constitution – each state's compliance was optional. Joseph Smith's platform to run for the presidency of the United States of America was to correct these two flaws. After Joseph Smith's death in 1844, Abraham Lincoln had all ready taken on this task in 1838. Abraham Lincoln was inaugurated president on March 4, 1861. He was assassinated in April 1865.

Miraculous events occurred within the legislature of the United States of America, which allowed for the abolishment of slavery and measures to force compliance of all states to the constitution. Lincoln is quoted as saying that "He from whom all blessings flow must not be forgotten" and that "no part of the honor is mine".

#### LEHI CHAPTER - Lehi, Utah

The Lehi Chapter members welcomed Phil Hanks, youngest grandson of Ephraim Hanks, as February's guest speaker. Phil served as a mission president in Samoa at age 28, a stake president, multiple missions with his

wife, Dawn, Temple President in Samoa, and a professor at BYU. He was accompanied by his wife, as well as several family members, and shared some highlights of his wonderful pioneer ancestor's life.

Born in 1826, in Madison, Ohio (part of the Connecticut Reserve), Ephraim lived with his parents and siblings near the shores of Lake Erie. Ephraim's father and mother were 'strict' Baptists and raised their family to be honest and useful. There was also an expectation to care for things around the home, including their horses. Because Ephraim failed to brush down a family horse after a hard ride, a "harsh punishment" was sure to be meted out and he chose to leave home at the age of 16. Phil then shared several stories of Ephraim's life, including how he came to be a member of the Church.

Ephraim enlisted in the Navy and served aboard the USS

Columbus. After being discharged in 1844, at the age of 18, he returned to his parents' home to find that his father has passed away. An older brother, who was a missionary for the Church of Jesus Christ of Latter-day Saints, also died following an illness and was buried at sea. Ultimately, Ephraim left home, once again, this time to search for another older brother, whom, it was believed, had been led away by the Mormons and was "under a spell." Ephraim then left for Nauvoo to "rescue him".

And so begins the wonderful story of Ephraim, his conversion to the gospel, and the great power of the Priesthood he held after accepting the gospel into his life. His rescue of the Willie Handcart Company is one that will never be forgotten. He was loyal to President Brigham Young and the other leaders of the Church – and was always willing to serve in whatever way he was asked. He is, to this day, a true here to Phil – and members of the Church around the world.

Phil is acknowledged at the end of the film, "Ephraim's Rescue", and has written extensively of his grandfather's life. Additionally, Phil authored a book on the life story of Ephraim Knowlton Hanks, entitled "I Am Ready Now" in which many of Ephraim's "miracles" are recounted. Many, many thanks to Phil, his wife, and their testament of service and pioneer heritage.

Lyman King presents Pioneer Minute on Martha Ann Smith Harris. Lyman King spoke on Martha Ann Smith Harris who was born in 1841. She was the daughter of Hyrum Smith and Mary Fielding Smith and sister of Joseph Fielding Smith. Martha as a young child in Nauvoo, remembers the death of her father and uncle and the sorrow and suffering of the saints. Lucy Mack Smith, her grandmother, had a dog named Tig who she would send to the store with a basket and who would bring home groceries.

Mary Fielding came west and settled in Millcreek on 40 acres. Her home is now on display at This is the Place Heritage Park. Martha became good friends with William Harris who was called on a mission. William went to the endowment house to receive his blessings and to be set apart. At which time Brigham Young asked if he knew a young lady that he thought enough of to marry? William said, "Yes, I do." Brigham Young said, "Bring her right here, right now, and be married before you go." Martha was surprised when Willam met her that afternoon and said, "Get your sun bonnet, we are going to get married." Martha turned to her soon to be motherin-law and said, "What shall I do?" Mrs. Harris said, "Get your Calico dress and go with him." They were married April 21, 1857 by Brigham Young.

John Mabey spoke on Grandpa Walter Mabey. John Mabey's grandfather passed away in 1957 at the young age of 63, brought on by a head injury sustained in World War I. John knew very little about his grandfather, except that his grandmother Ethel said that Walter knew the poem "In Flanders Fields" by heart. He would recite it at night in his home in South Jordan. He had apparently recited it every night during the war ending with the last stanza:

Take up our quarrel with the foe;
To you from falling hands we throw
The torch; be yours to hold it high.
If ye break faith with us who die
We shall not sleep, though poppies grow
In Flanders Fields.

Before leaving for the war Walter received his patriarchal blessing. The blessing promised him that he would return from the war safely. He put the blessing in his front pocket and kept it there until he returned home.

He fought in the Meuse-Argonne campaign, the largest offensive in U.S. military history. 1.2 million Americans soldiers fought in that campaign, 26,277 gave their lives, and tens of thousands more were wounded. Among those who gave their lives was a cousin of Walter, who is buried in Flanders Field. Is this the reason Walter recited the Fanders Fields poem each night? On October 4, 1918, Walter was missing in action, wounded on the right side of his head. For his bravery he received a Purple Heart. The patriarchal blessing he kept in his pocket became a reality as Walter arrived safely home to South Jordan, Utah.

#### MORGAN CHAPTER - Morgan, Utah

Janelle Frankie, a former member of the Tabernacle Choir, was the guest speaker for this month's luncheon meeting. Born and raised in Arkansas, she was the seventh of ten children. She started taking piano lessons at the age of 9. She sang in choirs in junior high and high school as well as in college. She earned a Bachelors of

Music Education at the University of Central Arkansas and taught elementary music for three years. She served a mission in the Pennsylvania Philadelphia Mission and then became a member of the Tabernacle Choir before she married Rob Frankie. They moved to Morgan in 2015.

Frankie shared the process a person must go through in order to become a member of the Choir. While living in Idaho she realized that with the musical skills she had acquired, she could become a member of the Choir, if she lived in Utah. After living in Washington State for a while, her brother invited her to live with him in Utah in 2007. When she decided to seriously consider the process for the Choir in 2008, she learned that because the Choir was transitioning

to new leadership, they would not be auditioning for new members that year

In 2009 she started the three-phase process. The first phase is the application. The application cover page provides information of the Choir's mission; to become an ambassador for the Church. It stresses the unique opportunity it provides to give missionary services through performances that it is extremely time consuming and becomes the member's primary church calling. Applicants are asked to consider the impact on family, job, and other responsibilities. The application has specific questions that must be answered. The Bishop then prepares a worthiness recommendation and submits it to the Church. The applicant also makes a recording demonstrating specific musical abilities and submits that to the Church.

After what seemed like forever, Frankie receive a letter informing her she was accepted to move on to phase-two of the process, which is the testing process. This phase consists of a music skills test. She was able to receive a study book to help prepare her, but she felt that a large part of the test, such as sight reading and hearing certain tones, could not be learned from a book, but from experience. Sight-reading is especially critical for a Choir member. Often times there is music presented with little time to prepare. Frankie successfully completed the music skills assessment and was

able to move to phase-three, the "In Person" audition. She was scheduled to meet with Choir Director Mack Wilberg, and Associate Director Ryan Murphy. She was asked to sing a Hymn of her own choosing and to demonstrate various other musical skills, such as sight-reading and vocal range.

She later received a letter inviting her to participate in the Chorale and Choir School, the final preparatory stage before being accepted into the Choir. The Chorale and School meet from January to early May. Attendance is mandatory. The Chorale and School each meet on separate days each week, the Chorale working on music and other skills and the School giving indoctrination on how you are to sing and what is expected of you in the Choir. An applicant who successfully completes the Chorale and School is accepted into the Choir.

Being in the Choir is a calling, with members being set apart as Music Missionaries. They are to sing and be seen by the world and require the enthusiasm of a volunteer and the discipline and responsibility of a professional. Although an all-volunteer ensemble, the Choir performs in professional arenas of broadcasting, recording, and concertizing and is heard by a worldwide audience that has come to expect excellence in performance. Participating in the Choir is demanding and time consuming. The Choir meets on Thursday evenings and prepare for 2 ½ hours. On Sunday mornings they arrive early at the Tabernacle and change into their wardrobe and then run through the music for Music and the Spoken Word. They then do a full run through with camera angles are practiced. After a short break they return for the live broadcast.

In addition, if there are upcoming concerts, conference, recording sessions, or other programs, they will stay after the broadcast to practice and have additional rehearsals throughout the week. Frankie read a part of her journal that described the tender feelings in her heart that she was experiencing and how the message of the music can have such a powerful effect and then sang Pilgrim's Song, stopping after each verse to read her feelings as recorded in her journal the first time she sang this song. In closing, she related how the Choir is often referred to as "the train that never stops". It keeps going. Members get on for a period of time and then get off when their time is done. But the train just keeps going and keeps on improving.

#### MT NEBO CHAPTER - Payson, Utah

project 6,000 miles from there in Mali, West Africa. Mali is one of the poorest countries in the world and is home to 19 million people. The rural settlements have no sewer or garbage management, so one can see sewage running down the dirt streets and garbage piled everywhere.

Because of the deplorable living conditions out there, Chris is building a chicken farm that will have a positive influence. It is hoped that the operation will not only provide food and employment, but that it will give the people hope. The operation began with 5 thousand chickens, is now at 20 thousand, and will soon have 30 thousand. It began with a dirt floor building and chickens laying eggs anywhere, but is now a modern sanitary building with equipment imported from Italy. Their goal is to soon be able to make a profit, and to use that money to build schools.

The Shepherds are certainly modern day pioneers!

Jeff is Oglala Lakota Native American from the Pine Ridge Reservation in South Dakota. His people are Sitting Bull and Crazy Horse, Spotted Tail, Rattling Blanket Woman, Rain In The Face, Horn Cloud, Her Iron Cane, and Iron Hail. He holds the birthright on both patriarchal and matriarchal lines to be a medicine man.

Jeff told that when he was five years old his family was the first family in their reservation town to join the Church of Jesus Christ of Latter-Day Saints, baptized on December 31, 1966 signifying a new beginning in their lives. Jeff's parents sent out some of their children to be part of the Indian Placement Program of the Church of Jesus Christ of Latter-Day Saints. Jeff lived with the Altom family in Oakley, Idaho. After high school Jeff attended BYU, having to cut his waistlength hair for admittance standards.

Jeff, who is a career law enforcement officer and works with many who have lost their path. He told of how he came to recognize the similarities of the Gospel with the traditions of his ancestors. Jeff told of traditions that portray the Godhead, the 12 apostles, the coming of Christ to the new world, and many others. We appreciated Jeff coming from South Dakota to share his story with us.

Palmyra, New York, they saw a sign for Kirtland, Ohio. They knew the historic value of the location as it relate to The Church of Jesus Christ of Latter-day Saints and decided that they would take a few moments and stop by. While in Kirtland, they were impressed to stay much longer and tour sacred sites. This led them to a decision to go on a mission. One of those visions, and perhaps the most well known, was the appearance of the Savior to Joseph Smith and Oliver Cowdery in the Kirtland Temple just prior to the Kirtland Temple dedication. "The veil was taken from our minds, and the eyes of our understanding were opened. We saw the Lord standing upon the breastwork of the pulpit, before us, and under his feet was a paved work of pure gold, in color like amber."


Joseph's Second Vision discussed occurred on the Morley Farm. God the Father and Jesus Christ appeared to Joseph Smith, Lyman Wight and Harvey Whitlock. This revelation was received at the farm log schoolhouse on June 4, 1831 during the Fourth General Conference of the Church.

Joseph's Third Vision occurred on the Johnson Farm on February 16, 1832. Philo Dibble wrote of the event, "Joseph wore black clothes, but at this time seemed to be dressed in an element of glorious white, and his face shone as if it were transparent."

Joseph's Fourth Vision discussed was during the School of the Prophets and occurred on March 18, 1833. Both the Father and the Son were present. Joseph Smith told those present, "Brethren, now you are prepared to be the apostles of Jesus Christ, for you have seen both the Father and the son and know that they exist."

Joseph's Fifth Vision occurred in the Kirtland Temple, Upper court, West Side in Joseph's office. Significantly, it was recorded as Doctrine and Covenants 137 where the doctrine of salvation for the dead is revealed.

Especially prominent in the presentation of Brother Poulos was the realization of the sacredness of each of these and other revelations that took place in Kirtland. Kirtland is significant for the number and the importance of revelations received. The Savior appeared in Kirtland eight times, four times with the Father. When one studies the history of Kirtland and the revelations received there, testimonies become stronger and sure of the divinity of the Lord Jesus Christ and Father in Heaven.

The following are the new Election procedures as approved by the National Board in 2017! Read carefully and Nominate someone between April 1 and April 30, 2019!

#### **ARTICLE 8 NOMINATIONS AND ELECTIONS**

Section 8.1 National Nominating Committee: Nominees for the position of National President-elect shall be selected by a committee comprised of three (3) members selected from the Past National Presidents Council, three (3) members of the National Executive Council, one (1) current Area Vice President, and the Immediate Past National President, who will serve as the chairman of this Committee, but will vote only in the case of a tie vote. The chairman shall determine the time and place for the meetings of the Committee and shall give notice of such meetings in a timely fashion. The Committee shall consider all candidates nominated for National President-elect by any current active member of the Society of the Sons of Utah Pioneers and shall select two candidates who meet the requirements for the office of National President-elect as described in Section 8.2, and are deemed most qualified. If a nominee shall withdraw before the National Encampment, the Committee shall nominate another candidate.

Section 8.2 Requirements of Office for National President-elect: A candidate for the office of National President-elect must have served for one year in at least one of these offices: Area Vice President, a National Program Director, or Chapter President. He must be an active member of a chapter, be current in the payment of his dues, and must give written consent to his nomination stating that he will be able to discharge the duties of his office.

Section 8.3 Nominations for the office of National President-elect may be submitted by any active member of the Sons of Utah Pioneers. Self-nominations are also welcome. No later than April 1st of each year an announcement will be transmitted to every member that nominations are open and encouraged. Acceptance by a nominee must be confirmed and validated by completion of an acceptance form and submitted to National by April 30. A copy of the nominee's personal summary and a written statement of the nominee's interest in serving as National President-elect, neither of which shall exceed one type written page, is necessary to complete the nomination process.

<u>Section 8.4</u> No later than May 15th the National Nominating Committee shall meet and, through personal interview and review of nominee documents, select the two nominees to be the finalist candidates in the Society's general election. The finalist candidates' personal summary shall be made available through the Trail Marker and communication to all chapter presidents and members, according to current election policy.

Section 8.5 The general election will take place during the month of August. No later than August 1st an

official ballot and the personal summary for each of the two candidates shall be mailed to every active SUP member of record. Voting will occur by returning the official ballot to the SUP Headquarters, postmarked by August 31st.

<u>Section 8.6</u> No later than September 10<sup>th</sup>, all votes shall be tabulated. The two candidates will be notified of the results at the discretion of the Nominating Committee. Public announcement of the election results and swearing in of all new National executive officers will be held at the National Encampment. The term of office for the Elected Members of the National Executive Council will begin and end with the National Encampment each September.

The following is required to place anyone in nomination for National President Elect for 2020:

- 1. Name and Chapter of Member making nomination.
- 2. Name and Chapter of Nominee
- 3. Nominee's personal summary (not to exceed one page).
- O. Nominee's Statement of why interested in serving.
- 1. Nominee's signed & Dated permission agreement.

Thomas G Alexander is Lemuel Hardison Redd, Jr. Professor Emeritus of Western American History (BYU). He has authored, co-authored, edited, or co-edited twenty-eight books and monographs and numerous artricles, including Utah, the Right Place: The Official Centennial History (3rd ed. 2012, prizewinner), Things in Heaven and Earth, the Life and Times of Wilford Woodruff, a Mormon Prophet (2nd ed 1993, prizewinner), and Brigham Young and the Expansion of the Mormon Faith (forthcoming, 2019). He was president of several historical organizations including the Pacific Coast Branch-American Historical Association, Phi Alpha Theta (the history honor society), and the Mormon History Association. Church service includes high councilman and bishop. He is married to Marilyn Johns Alexander. They are parents of five children and six grandchildren.



Ronald G Watt was born in Carbon County, Utah, graduated from Carbon High School and Carbon College. He received a B.A. and an M.A. from Utah State University. He took additional graduate classes from the University of Minnesota where he received a Ph.D. He worked thirty-five years for the archives of the LDS Church Historical Department, now retired. He is author of over twenty articles and four books including A History of Carbon County and The Mormon Passage of George D Watt, First British Convert Scribe for Zion which won the David W. And Beatrice C. Evans Handcart Award. He presently is on the Board of Editors for the Utah Historical Quarterly. He is married to Barbara Fluckiger Watt, and they are the parents of six children. He served int he British Mission in his younger years and served with his wife in the Baltic Mission in Lithuania. He is the past president of the Proter Rockwell Chapter of the Sons of Utah Pioneers.



Daniel B. Kuhn, Railroad and Freight Planner, Utah Department of Transportation (UDOT)
Daniel B. Kuhn is a fifth-generation railroader with family connections to the rail industry in the
United States going back to the 1800s. Daniel was an official with both Southern Pacific and
Amtrak prior to coming to UDOT in 1999 as the state's Railroad & Freight Planner. His
background includes teaching and lecturing about various aspects of transportation, history and
geography since 1966 and he has performed on-site research in all 50 states and across
southern Canada. In his current role Daniel maintains a close working relationship with all
freight industries that impact Utah, including not only the railroads, but the trucking industry,
pipeline systems, air cargo operators and west coast seaports.



Dr. Wayne K. Hinton is President-elect of the National Society of The Sons of Utah Pioneers. He has been a chapter president, and A.V.P. and an active member in many other historical organizations. Wayne has degrees from Dixie State, Utah State University, Brigham Young University and a post-doctorage from University of California, Davis. He taught history at Southern Utah University for 38 years, 18 of those he served as Department Chair. He has written four published books, chapters in eight other books and has presented papers at numerous professional conferences and has published over fifteen article in professional journals.



Elder Steven E Snow was called to serve as a member of the First Quorum of the Seventy of The Church of Jesus Christ of Latter-day Saints in March of 2001. He currently serves as Church Historian and Recorder and is the Executive Diretor of the Church History Department. Prior to his call to serve as a full-time General Authority of the Church, Elder Snow was a senior partner in the Utah law firm of Snow Nuffer. The St George, Utah native attended Dixie College and earned his bachelor's degree in accounting at Utah State University and his law degree at Brigham Young University.


Elder Snow and his wife, Phyllis Squire are the parents of four sons.
