

PRESIDENT'S MESSAGE



Well, here we are headed into a brandnew year! 2016 was a very interesting and different year in many ways, but, as far as the Sons of the Utah Pioneers is concerned, it was a great year. Under the direction of our National President James C. Hurst, and our immediate past president Tom Alexander, we made many great strides forward in the management

and financial operations of the association, the biggest being the "Heritage Pioneer Sustaining Fund", which was put in place in April. This fund will allow us to cover major operating expenses without going out to the general membership every 3 to 5 years seeking extra donations. Also, Jim and Tom were able to secure major financial grants which have allowed us to do some important upgrades to our building such as new carpeting, a new sound system, and repairs of the leaking roof. This coming spring we will be resurfacing our parking lot.

"The National Society of the Sons of Utah Pioneers" will be 84 years old in 2017. It was organized on March 29, 1933, through the efforts of 10 men in one chapter. The national dues that year were \$1.00, and

remained that amount for many years thereafter because of the Great Depression and post-depression era. In 1999 the membership was 2000 in 42 active chapters.

As of the beginning of this year, we have a membership of 2055 in 46 active chapters, however, we have 301 members who are unaffiliated with any Chapter. They are our "At Large Members." The only contact they have with membership is through the "Pioneer Magazine" and the Internet-based "Trail Marker".

One of my goals this year is to bring to the "At Large Members" more and better contact with the Association through modern technology such as the Internet, videos, Social Media and organizing a new "Online Chapter." Along with this enhanced contact, we need to make our programs more attractive to youth as well the older generation.

I am looking forward to a great year in 2017. As national president, I will strive to bring the Association more fully into the technology era, and bridge the gap between generations, which will surely benefit both.

The ideals and purposes of the National Society of the Sons of Utah Pioneers have always been:

- 1 To preserve, by worthy endeavor, the heritage of our pioneer forefathers, and
- 2 To foster the same spiritual elements of success of the pioneers who conquered, transformed, and settled the great wilderness of the West: namely faith in God, devotion to family, loyalty to country, freedom of conscience, commitment to work, service to others, cooperative industry, and indomitable integrity.

It is our responsibility to share these important concepts with the younger generation, and make them fully aware of these values. This is my goal for 2017.

PIONEER MAGAZINE (BOOK) UPDATE



The special combined issue of Pioneer magazine is printed and is available.

The 232-page book has been delivered to the Post Office for mailing to all members and subscribers. It is also available for purchase at the Church History Museum, and at SUP

Headquarters. It will shortly be available on-line from the SUP Store.

The new book presents a walking tour in print of the one-year-old exhibit at the Church History Museum entitled "The Heavens Are Opened: The Early History of the Church of Jesus Christ of Latter-day Saints." The Museum is located on West Temple St. in Salt Lake City, immediately west of Temple Square.

The "Heavens Are Opened" exhibit includes many video and interactive graphic presentations, as well as a new film depicting the First Vision. Included throughout are important historic artifacts from the early days of the LDS Church in New York, Ohio, Missouri and Illinois. All of these are documented in this beautiful new book published by the Sons of Utah Pioneers. Some who have already seen the book have commented that it is almost better than the actual exhibit, because the reader can focus on the stories and artifacts one page at a time.

The new book represents issues 2, 3 and 4 of the 2016 volume of Pioneer magazine. Regular quarterly Pioneer magazine issues will resume during the first quarter of 2017, and continue normally throughout the year.

We are grateful for the patience and trust of our subscribers as you have awaited this new publication. We are hopeful that you will find the new book to be worth the wait.



MODERN DAY PIONEER

We have been striving to start a new feature to honor some of our members who are modern day pioneers. We recently received information on a significant memorial project that is being developed in Great Britain. While we have many monuments here in the United States, there are relatively few in Great Britain, so we are passing this on for your information.

The project revolves around this old farmhouse built in 1750.



The farmland once connected with this farmhouse was sold to The Church of Jesus Christ of Latter Day Saints in 1992. The Preston Temple, the Preston MTC and the Stake Center, were built on that land and dedicated in 1998. Land that once grew crops and raised cattle is now harvesting and nurturing a spiritual crop.

Now, some eighteen years later, the Harwood farmhouse and the neighboring temple gardens are about to be reunited with the common purpose of turning the hearts of the children to their fathers.



A Memorial Wall with engraved granite walls, statues, stained glass, gardens and a Visitor Center will be erected to recognize:

- British reformers such as John Wycliffe, William Tyndale, George Wishart, John Knox, etc.
- Translators of the King James Bible
- Passengers of the Mayflower
- 400 Protestant martyrs and 380 Catholic martyrs through whom we enjoy religious freedom
- Amazing work of Restoration forerunners such as John Wesley, John Bunyon, George Fox, George Whitford and others
- British musical contribution
- Influence and faith of many British authors, poets and statesmen
- Victorian LDS emigrants who saved the early Church (many of whom are probably your ancestors)
- "Stay and build" pioneers of the 1950s and 1960s

Such a rich tapestry of faith is worthy of recognition and remembrance. Likewise the memorial is designed to record significant milestones, such as marriage and death of current Church members – a permanent reminder of love and legacy engraved forever in stone. Within the Visitors Center, photos, stories and artifacts will tell the British story and missionaries will be able to add their details to the Mission Wall. We are also teaming up with some sculptors and stained glass artists who will create a visual feast of inspiring art work which can be memorialized in honor of your ancestors.

Details of this project are still coming.



REFLECTIONS ABOUT AMOS COX

FROM THE PEN OF CLEESA COX ~ SUBMITTED BY DAVID HINTON



Amos Cox

Amos Cox, born 8 October 1856 at Manti, Sanpete County Utah, was the son of Orville Southerland and Mary Elizabeth Allen Cox. When Amos was a small boy they were called to go to the Muddy in Nevada and settle that part of the country. After many L.D.S. families had built canals set out orchards and vineyards and got the land to producing, the State of Nevada set such a high tax that the Saints

were unable to meet it. We were told to get out, so grandfather and grandmother moved to Orderville, Utah where they later joined the Order.

Father remembered the long tables where everyone ate and where the butter was put on the bread and then scraped off so it was called bread and scrape, but he also remembers some very good meals that were served, which tasted especially good after a long day of working with a hand scythe.

My father as well as Sister Brady Englestead has told me of how her sister who was about 14 years old had been sick for months, and got so she wouldn't eat, and although they had the elders administer many times, still she seemed to get worse. One day she said "If you will have Amos Cox administer to me I think I will get well." Father was only 17 years old at the time and had never administered to anyone in his life, but they sent for him out in the field where he was scything grain. He said he was dumbfounded, but told them he would come. There in the field he asked Heavenly Father what to say and said he believed it was one of the most humbling experiences of his life. He went to the house, washed his hands, and sealed the anointing. He promised the girl that she would get well, then when he looked at her and saw how frail and pale she looked, he was scared and so weak that he had to sit down. In a few minutes the girl asked for some bread and milk. She ate all of it, and wanted

more, but her mother was wise and told her that she must not eat too much at once, but could have more later. Father then went back to the field. The girl improved from that day on and lived to raise a large family.

Father seemed to have the gift of healing. I have seen several persons whom the doctors had given up, but lived after father administered to them. I also saw a case of someone who didn't live, but father was using tobacco at the time as a doctor had told him to so as to remove the fat from around his heart, but father felt that was why the Lord did not hear his prayer, because he was breaking a commandment.

Father was married to Sarah Arletta Palmer 10 July 1876. I think it was in the Endowment house; anyway he said he was endowed in Salt Lake City. After they had been married a number of years they had no children. It was during the time of polygamy and as the government was trying to get the manifesto through. Father went to Mexico and married my mother Grace Ellen Chestnut on the 4th of June 1894. They were married by Brigham Young Jr., son of President Brigham Young, who was down there for that purpose.

Father and mother are the parents of eight children. As there were no doctors in the L.D.S. Colonies at that time, Aunt Letty took care of the confinement cases with father's help sometimes in Chuichupa, Garcia, and Pechaco, the Mountain Colonies. Later they did some of that work in Colonial Juarez. Father also set broken bones, extracted teeth, and treated snake bites. He said that with the help of the Lord they never lost a case.

Father also practiced the blacksmith trade and went as a guide with mining men from Boston and other Eastern cities. When I was about 12 years old, father sold a mining claim for five thousand dollars and we moved to Juarez. Father invested part of the money in the electric light company and bought a blacksmith shop and a home with the other part. We had electric lights, a telephone, an Edison Phonograph and linoleum on the floors, something we had never had in Chuichupa. Also an organ of which we girls were very proud.



Joseph Smith from 1833-1837, built his remarks around the multiple references to his ancestor in the Doctrine and Covenants. From these citations, we learn of the many roles Dr. Williams played in early church history. Besides being the Prophet's counselor, they included being scribe to the prophet, a member of the first high council for the Church, printer for the early LDS hymnal and Book of Commandments, physician for the citizens of Kirtland, justice of the peace in Kirtland and contributor of land for the Kirtland Temple and other Kirtland buildings. He moved to Missouri with the Saints and then back to Nauvoo where he died in 1842 in full fellowship in the Church. His wife and son, Granger, emigrated to Utah and maintained the Williams heritage in the West. The evening provided a rich understanding of this important yet often unrecognized early church leader plus the bonus of Sister Williams' history and musical talents.

MILLS CHAPTER - Salt Lake City and Millcreek, Utah Areas

Our December meeting featured the Utah Chamber Artists. They are based in Salt Lake City, Utah and were established in 1991 by Music Director **Barlow Bradford**. The ensemble consists of forty singers/players. Besides presenting the traditional and revered repertoire of the past, the group provides audiences with contemporary works and regularly commissions new music. The musicians perform out of their love for great music and a genuine desire to enrich the lives of their listeners.

Utah Chamber Artists is a major artistic force along the Wasatch front in Utah, but they also enjoy a broader reputation. The choir has been heard on the National Public Radio program "First Art," appeared on the Mormon Tabernacle Choir's weekly broadcast, performed with Keith Lockhart and the Boston Pops Esplanade Orchestra, and sung on various occasions with the Utah Symphony. In 1996, the choir was invited to perform with the Israel Chamber Orchestra. Dr. Bradford conducted the ensembles in a concert tour of Israel, which culminated in a studio recording of the John Rutter "Requiem."

PORTNEUF CHAPTER - Pocatello, Idaho

The Portneuf Pioneer December Gold and Green Ball was another wonderful success. The Dance was held in the historic Tyhee Church just north of Pocatello. We danced the night away to the music of **Steve Riley**. The hors d'oeuvres were heavenly with cookies and punch and all kinds of treats. The floor show included a Christmas concert by "Praise Ensemble " singers led by **Wayne Winters**. The December Chapter Meeting speakers were the new 2017 Chapter President, **Dr. Mark Bezzant** and his wife Colleen Bezzant.

Colleen Bezzant was the first to speak and gave accounts of Pioneer stories of her family and personal experiences that she had. She spoke first of the

Christmas spirit and the sacrifice Jesus

Christ made for all of us. She then spoke of her wonderful heritage beginning with a great grandfather who was taught the gospel in England by Wilford Woodruff before joining the church. He came to America just as the mobs were driving the saints out of Nauvoo. He later joined the Mormon Battalion, became ill on the trek and was left on the side of the road as if dead. An individual appeared and administered to him and then disappeared. It was thought that the individual may have been one of the three Nephites.

Colleen spoke of a faithful grandmother who lived to be ninety-nine and a half years old and who had spent the last ten years of her life in bed. Colleen went on to discuss her own family and how they all worked in a hardware store and learned the skill of how to treat people. Her mother had taught her to "kill them with kindness." Colleen reminded us that we should all carry the light of Jesus Christ to the world.

Mark's mother had a disease that damaged her heart; consequently a doctor suggested that she have an abortion due to her poor health. However, she had a priesthood blessing that she would grow to maturity and have a family. There would be no abortion! Mark's mother went on to raise 7 children and lived to the age of 74.

Mark related stories of Colleen's ancestry and a great great grandfather, Eli B. Kelsey, who was the teacher for the children of Joseph and Hyrum Smith when word came of their deaths. Eli was so admired by Brigham Young as a teacher that Brigham asked him to be the principal of the school in Salt Lake City where Brigham's many children were educated. Eli crossed the plains four or five times bringing others to Zion.

Mark related how the Bezzant's came to Pleasant Grove and through much hard work helped turn the desert into a rose. Mark spoke of how he almost drowned as a two year old, but was saved by a noble woman who was listening to the spirit. He stressed the need for all to keep the heritage of the pioneers alive and pass the torch to the next generation, never letting it die until that blessed day when Christ comes again.

TEMPLE FORK CHAPTER - Logan, Utah

Russ Akina was the Temple Fork Chapter November speaker. He is Director of Parks and Recreation for the City of Logan. He began his talk with a bit of information about himself, how he got employment in Logan, and how he feels about Logan and Cache Valley.

He had lost his job and was looking for a new one. He got a call from his sister in 1994

saying there was a position open in Logan, Utah. He sent a resume and then came to Logan to interview.

As he drove into Cache Valley, it reminded him of "Little House on the Prairie." He saw all the green and fell in love with the Valley. There have been a lot of changes in population and recreational activities in the Logan area since that time.

The Logan Parks and Recreation Department has a stewardship for over 397 acres of parkland, 32.6 miles of trails and trail connections, 44 youth and adult recreation programs, the Logan City Cemetery, Logan River Golf Course, Logan Aquatic Center, Logan Skate Park, and the Logan Recreation Center.

This position has helped Russ learn to sharpen his communication skills. He knows it is important to listen and to respond to concerns of the public. He believes that whatever we do in the public eye, everything matters.

Russ is an advocate for public trails. One of his responsibilities has been to acquire property along the Logan River from private individuals so that there is land for trails. Many people do not want trails or a park next to their house. Most projects have challenges; planning is very important; and sometimes projects take longer than he had hoped they would take.

The Temple Fork Chapter of Sons of Utah Pioneers recently presented a Modern Pioneer Award to Casper's Ice Cream, Inc. and Paul Casper Merrill the current Chief Executive Officer.

The development and growth of Casper's Ice Cream has been a pioneering effort by three generations of the Merrill family. The business was started in 1925 by Paul Merrill's grandfather, Casper W. Merrill. Three of Casper's four sons—Richard Merrill, Derwin Merrill and George Kay Merrill—have spent many years in the company with responsibilities for management, production, accounts, sanitation, engineering, sales, and marketing. Most of Casper's granddaughters and grandsons and many spouses have also worked in the family business.

Casper started the business by taking some of the milk and cream from the family dairy farm and making ice-cream mix in a ten-gallon milk can. He froze the mix into Casco nut sundaes and Fat Boy ice cream sandwiches, he then sold them at Richmond's Black and White Days, the 4th and 24th of July celebrations, and the Cache County Fair and Rodeo. He taught his four sons to hawk (sell) them at the Rodeo by yelling: "I scream, you scream, we all scream for ice cream. It will freeze your teeth, curl your hair, and make you feel like a millionaire. Only 10 cents."

Casper Merrill had a great philosophy of life and left a legacy that people could be successful in life if they would work hard, pay a full tithing, spend less than they make, save for the future, and serve in their church and community.

Consequentially many of Casper's posterity have served in presidencies of Relief Society, Primary, Young Men, Young Women, Stake Presidency, High Council, Scouting, Mayor, City Council and other church and civic positions.

When Casper retired, Paul's father, Derwin Merrill became Chief Executive Officer. Under his direction, the Fat Boy manufacturing was changed from a batch-freezing operation to a continuous-line operation using a tunnel freezer designed and built specifically for Casper's Ice Cream.

Paul Merrill is the third-generation Merrill operating Casper's Ice Cream. Paul graduated from the School of Business at Utah State University. He is very optimistic, a great organizer, and has a keen ability to rally midmanagement corporate employees around the company goals and mission statement.

When Paul became President of the Company in 2002, annual sales were at \$4 million. In 2016, the sales surpassed

\$30 million, which equates to producing over 80 million novelty ice cream bars. These Fat Boys are sold in over 6,800 grocery, C-store, and club stores in the United States. With the completion of a new 75,000 square-foot factory being built, Casper's production capacity will allow sales to grow to four times the current sales.

From its beginning, Casper's Ice Cream has manufactured Fat Boy ice cream sandwiches and nut sundaes on a stick. In addition to producing Fat Boys in several different flavors, Casper's Ice Cream. has recently begun selling numerous flavors of ice cream in two-quart containers under the "Red Button" label. They also co-pack ice cream products with several different labels for other companies.

Paul is certainly a Modern Pioneer in an ice cream business that has been pioneered through three generations of Merrills.


